कार्य का नाम : 2024-25 के लिए सदाशिवनगर, बेंगलूरु में सीपीआरआई कार्यालय परिसर की वार्षिक मरम्मत एवं अनुरक्षण। उपशीर्ष: स्क्रैप को हटाने के लिए ट्रैक्टर का उपयोग करना, सीपीआरआई परिसर में डिवीजनों में पड़े बेकार और अनुपयोगी वस्तुओं के परीक्षण किए गए नमूनों को परिसर में स्क्रैप यार्ड में स्थानांतरित करना।

महानिदेशक, केन्द्रीय विद्युत अनुसंधान संस्थान की ओर से निम्नलिखित कार्य के लिए इस दस्तावेज़ में नीचे निर्दिष्ट एजेंसियों / फर्मों से “स्क्रैप को हटाने के लिए ट्रैक्टर का उपयोग करना, सीपीआरआई परिसर में डिवीजनों में पड़े बेकार और अनुपयोगी वस्तुओं के परीक्षण किए गए नमूनों को परिसर में स्क्रैप यार्ड में स्थानांतरित करना” के लिए मुहरबंद मद-दर दरसूची (मद-दर नीचे अनुसूची ए में उद्धृत करें) आमंत्रित हैं। विहित खाली कोटेशन फार्मों को संयुक्त निदेशक, सिविल इंजीनियरी प्रभाग, केन्द्रीय विद्युत अनुसंधान संस्थान, बेंगलूरु के कार्यालय से 31 मार्च 2024 को समाप्त पिछले वर्ष के दौरान कम से कम 25 दिनों की अवधि के लिए किसी भी सरकारी विभाग को किराए पर ट्रैक्टर उपलब्ध कराने के आवश्यक दस्तावेजी प्रमाण के साथ सबूत की प्रस्तुति पर प्राप्त किया जा सकता है। आवेदन देने पर 24/4/24 के 11.00 बजे पूर्वाह्न तक कार्यालयीन समय के दौरान सभी कार्य दिवसों पर अर्ह ठेकेदारों को खाली कोटेशन फार्म जारी किए जाएंगे बशर्ते कि वे समुचित प्राधिकारी से निश्चित सबूत पेश करें, जो संयुक्त निदेशक के लिए संतोषजनक हो। पूर्ण रूप से भरे कोटेशन on 25/4/24 के 3.00 बजे अपराह्न तक अथवा उससे पहले अधोहस्ताक्षरी के कार्यालय में पहुंचे कोटेशन देनेवालों की उपस्थिति में कोटेशन अनावरण समिति द्वारा उसी दिन 3.30 बजे अपराह्न को कोटेशन खोले जाएंगे। बिना कोई कारण दिए सक्षम प्राधिकारी किसी अथवा सभी कोटेशनों को स्वीकारने अथवा अस्वीकारने का अधिकार रखते हैं। सब कोटेशन जिनमें निर्धारित शर्तों में से कोई पूर्ण नहीं हों अथवा किसी तरह से अपूर्ण हों, अस्वीकृत हो सकते हैं।

Specifications, terms and conditions:

1. Unless otherwise specified, all items of work shall be executed as per CPWD specification 2019.

2. The scope of the work includes,
 - Hiring of tractor with trailer including cost of fuel and driver wages
3. Period allowed for completion of work shall be 6 months which shall be reckoned from the date of issue of work order or the actual date of handing over of work whichever is later.
4. The time allowed for completion of work is 6 months & shall be strictly observed by the contractor and shall be deemed to be the essence of the contract / work order. The contractor shall pay as compensation an amount equal to 0.25% of the estimated cost put to quotation or such smaller amounts to CPRI for every week the work remains unfinished after the proper dates, provided that the maximum amount of compensation under the provision of this clause does not exceed 2.5% of estimated amount put to quotation of Rs.1,80,000/-. The actual quantum of compensation payable by the contractor to CPRI for delayed performance shall be decided by the Chairman, High Power Committee CPRI, Bengaluru.

But if the work(s) is (are) delayed by:

- Force majeure, or
- Abnormally bad weather, or
- Serious loss or damage by fire, or
- Civil commotion, local commotion of workmen, strike or lockout, affecting any of the trades employed on the work, or
- Delay on the part of other contractors engaged by Joint Director in executing work not forming part of the Work Order, or
- Any other cause like above, which in the opinion of Joint Director is beyond the contractor's control

then upon the happening of any such event causing delay, the contractor shall immediately give notice in writing to Joint Director but shall nevertheless use constantly his best endeavor to make good the delay. He shall be granted extension of time in such case by Joint Director but shall have no claim of damages for extension of time granted, for any components of idling of work force and machineries, as it is expected that the agency should act immediately and accordingly to mitigate any such idling. The rates quoted shall not be changed under any circumstances, in such conditions.

5. The contractor must strictly follow the provisions of contract Labour (Regulation & Abolition) Act, 1970 of Government of India and 'The Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Act, 1996.
6. The contractor shall comply with the provisions of the Payment of Wages Act 1936, Minimum Wages Act, 1948, Employees Liability Act, 1938, Workmen's Compensation Act, 1923, Industrial Dispute Act, 1947, Maternity Benefits Act, 1961, or the modifications thereof or any other laws relating thereto and the rules made there under from time to time.
7. The contractor shall indemnify CPRI against payments to be made under and for the observance of the laws aforesaid and the Contractor's Labour regulations, without prejudice to his right to claim indemnity from his sub-contractors.
8. Whatever is the minimum wage for the time being, or if the wage payable is higher than such wage, such wage shall be paid by the contractor to the workmen, directly without the intervention of Jamadar and that Jamadar shall not be entitled to deduct or recover any amount from the minimum wage payable to the workmen as and by way of commission or otherwise.
9. The contractor shall ensure that no amount by way of commission or otherwise is deducted or recovered by the Jamadar from the wage of workmen.
10. The contractor shall follow the provision of CPWD safety code contained in CPWD General Conditions of Contract for Maintenance Works -2023 incorporating amendments upto circular bearing no. DG/CON/339 dated 01.08.2023.
11. The Joint Director may without prejudice to his right against the contractor in respect of any delay or inferior workmanship or otherwise or to any claim for damages in respect of any breaches of the contract/work order and without prejudice to any rights or remedies under any of the provisions of the work order/contract or other wise and whether the date of completion

has or has not elapsed by notice in writing absolutely determine or rescind the contract/work order.

12. Income tax at the prescribed rate shall be deducted from the contractor, at source, from the bills payable to him.

13. The contractor must arrange all the tools and plant, required for execution of the work at his own cost.

14. Water & Electricity required for the above said work shall be provided by CPRI free of cost. The contractor shall make his own arrangement for tapping it from the specified source at his own cost.

15. The rate quoted for the item of work shall be inclusive of all taxes and levies, but excluding GST, payable under respective statute. However, if any further tax or levy or cess is imposed by statute, after the last stipulated date for receipt of quotations, including extensions, if any, and the contractor thereupon necessarily and properly pays such taxes/levies/cess, the contractor shall be reimbursed the additional tax amount so paid, provided such payments, if any, is not, in the opinion of The Chairman, High Power Committee (HPC) (whose decision shall be final and binding on the contractor) attributable to delay in execution of work, within the control of the contractor.

(a) The onus of complying with the statutory obligations of making payment of GST to the GST department lies with the contractor. The contractor shall make mention of his GST No. and CPRI's GST No. in the invoice to be raised after completion of work.

16. Quotationers are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their quotations as to the condition of the buildings, the form and nature of the site, the means of access to the site, the accommodation they may require and in general shall themselves obtain all necessary information as to the risks, contingencies and other circumstances which may influence or affect their quotation. A quotationer shall be deemed to have full knowledge of the site, whether he inspects it or not and no extra charges consequent on any misunderstanding or otherwise shall be allowed. The quotationer shall be responsible for arranging and maintaining at his own cost all materials, tools and plants, electricity access, facilities for workers and all other services required for executing the work, unless otherwise specifically provided for in the quotation document.

17. Earnest money for an amount of Rs.3,600/- should be deposited along with the filled quotation in the form of DD / Banker's Cheque issued by any of Scheduled bank guaranteed by Reserve Bank of India. DD shall be drawn in favor of the Accounts Officer, CPRI, Bengaluru against EMD.

“The quotation for the work / supply shall have validity for 30 days from the date of opening of quotations. CPRI shall, without prejudice to any other right or remedy, be at liberty to forfeit 50% of the earnest money if any quotationer withdraws his quotation during validity period or makes any modification in the terms and conditions of the quotation which are not acceptable to the department, and to forfeit absolutely if the quotationer, whose quotation is accepted, fails to commence the work / supply specified in the NIQ (along with changes in scope, if any) in the prescribed time or abandons the work / supply before its completion.”

The quotation for the work / supply shall have validity for 30 days from the date of opening of quotations.

18. The EMD of the lowest bidder shall be adjusted against the Security Deposit in the bills payable to the lowest bidder.

19. Security deposit (SD) of 5% of gross value of the bill shall be recovered from the bill/s payable to the contractor. The same shall be refunded to the contractor after successful completion of the work and after making good of any defects in the work noticed during the maintenance liability period of one month from the actual date of completion of the work, among other conditions.

20. The decision of the Joint Director in all the matters arising out of the operation of the work order shall be final and binding.

21. Settlement of disputes and arbitration: In case of arising of any dispute on account of operation of this work order, based on this quotation the same shall be resolved in accordance with the provisions of clause 25 of CPWD General Conditions of Contract Form 7/8 of the edition CPWD GCC 2023 incorporating amendments upto circular bearing no. DG/CON/339 dated 01.08.2023.

21. Deviation limit applicable: 50% applicable for individual items of work. Any item of work executed beyond the stipulated deviation limit shall be paid based on the local market rate in accordance with provision of clause 12 of CPWD General Condition of contract -2023 incorporating amendments upto circular bearing no. DG/CON/339 dated 01.08.2023.

. The Joint Director shall have powers to alter, change and reduce the scope of the work, based on the situation at site. The agency who bids and is awarded the work shall have no claim whatsoever, due to such reduction in scope of the work.

22. Whenever the contractor brings any material into CPRI campus for use in execution of the work, he shall submit the photocopies of the corresponding bills, vouchers, delivery challans.

23. The lowest bidder who is awarded the work shall supply tractor as and when required by CPRI for a maximum of 65 days. The bill towards the number of days the tractor is hired in a month shall be raised by the contractor at the end of every month. The payment for hiring of tractor shall be based on time logging of the tractor i.e., inward and outward timing of the tractor to and from CPRI that is recorded by the security section. A minimum of 8 hours of working per day excluding lunch break is mandated. In case of shortage of working hours suitable proportionate deduction shall be made in the bills payable to the agency.

24. The following declaration shall be furnished by the quotationer at the time of quoting for the work.
